REACH – Chemicals in the EU

Dear Customer,

the European Union Regulation (EC) No 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) entered into force in 1 June 2007. REACH addresses the production and use of chemical substances, and their potential impacts on both human health and the environment. It requires all companies manufacturing or importing chemical substances into the European Union in quantities of one ton or more per year to register these substances.

For Mosca GmbH REACH has a high priority. All needs of this regulation were checked detailed. Furthermore Mosca Sales & Service GmbH & Co. KG will also constantly observe the REACH relevance of their products.

In all manufacturing processes Mosca Sales & Service GmbH & Co. KG neither produces new chemical substances nor imports material from non-EU countries. Therefore Mosca Sales & Service GmbH & Co. KG at present does not apply for registration. If a registration will become necessary because of any variation of the process, Mosca Sales & Service GmbH & Co. KG will inform you immediately.

By continuous reviewing of the safety data sheets Mosca Sales & Service GmbH & Co. KG is meeting the responsibilities as a downstream user (last check: 31.01.2024).

Article 33 of REACH obligates the supplier of a product, which contains material from "the list of candidates" in a concentration of more than 0.1% (w/w) to at least indicate to its customer the name of the material concerned. On processing new raw materials we review the relevance with this list. Should a material of "the list of candidates" be contained in a higher concentration than required, the necessary information will be attached to the product. If a substance already used should be taken up to the list of candidates, you will receive the information automatically. Mosca Sales & Service GmbH & Co. KG confirms that there have been no substances in very high concern (SVHC) in their products so far.
